

The truth about Linda Shelton

We have kept our peace for years. It's about time the truth about Linda's whereabouts for the last 19 years is revealed. Things have been very different than it seems.

This is our story.

Our names are Pia and Mette. We are the daughters of the Norwegian doctor.

Our mum died August 2003. Our father was devastated. We had actually never seen him in such a bad shape ever before. At that time we were all neighbors, and we are happy to say that it made it easier to care for him, and spending time together in our grief. Mette lived in the same house as him, our childhood home. This house was rebuilt and made into a semidetached house, so that we were able to live close to my mother the years she was really sick. This was an arrangement we all were happy with. My mum didn't have to be alone during her chronic illness, and her grandchildren got to spend a lot of time with her while she was alive. My mum and dad made us an agreement which stated that we were to inherit the house when they were no longer around. With that in mind we invested a great deal of money in the house, to make it the home we wished for. My father also bought a farm house next to this house for Pia and her family to stay in. She too invested money in the house, and was promised the same as Mette.

My mum died believing that her family were taken care of as she planned and agreed with our father. It was important and comforting to her before she died

We first met Linda early on in 2004. We were a little bit skeptical because she came on pretty strong towards our father. She was calling him at all times, and sending him e-mails. Sharing our concern with our father he assured us that he was absolutely not romantically interested in her. She was not his type, and also married. Linda painted herself as a victim. She vividly described her allegedly abusive husband, and all kind of horrible incidents. Our father was very quick dragged into her scam, and thought he was part of some kind of important rescue mission. He promised to take care of her, which later on would mean much more than he intended at that time. He became literally stuck with her.

Linda told our father that she was left penniless from her “crazy” ex-husband (we later learned that this was not true), and for that reason our dad gave her money almost from the day they met. He covered most of her living and travel expenses. There was not a day in between Linda leaving Mr. Shelton she had to take care of herself. He also paid for her court case against Mr. Shelton, which lasted for many years. It was said to be a loan, but when she lost there was not coming any money his way. Linda has been living with our father in Norway all these years. She has also stayed in his house in Florida in between, with him and sometimes alone. Later on they married in secrecy. During the years she made the impression at her website and other social medias that she was living alone. There is no truth to that. There has been a lot of secrecy and pretending.

When Linda started to attend our house we really tried our best to be friendly. Living as we did in our family, we were used to being together and having a lot of social- and dinner gatherings. She was not a social person. She didn't make any attempt to get to know anyone, and she didn't show any interest in anybody but herself. We talked English to each other in all social settings to include her, which actually was a big deal to us, not being comfortable with her language. One should think that living in a foreign country you could make a little effort to learn the language, the costumes and the culture. After 19 years in Norway is "Tusen takk" pretty much what she can say, which means thank you. She is constantly complaining about the Norwegian way of living, the people and the laws. She didn't put up any effort to try to be part of our family. In fact, I heard years later that she was complaining about us from day one. We really didn't have a chance with her. We were not part of her plan.

For many years we listened to all her horrible stories of persecutions and harassment from her ex-husband Mr. Shelton. At some point it became too much, and we started to question her insanity. When we read her book it became very clear to us that she is suffering from paranoia, among other things.

We can't prove that it ALL is a lie, but everything that supposedly happened in Norway is.

Knowing that made us pretty sure that the rest of the incidents also are fabricated.

Mette once confronted her with that. The book not being the truth. She just shrugged and said: "Well, it's MY story – and my

lawyer said it was ok”. She didn’t care about the truth, she only cared about not being caught.

Our family broke apart. Pia and her family moved away. Years later Mette and her family did too. The environment was hostile. We blamed our father. We just recently learned that he was heavily manipulated and not in a healthy state of mind suffering from minor strokes. Linda is currently living in the farmhouse. The other house is sold, and Linda is doing her very best getting her hands on the money from that sale and all the rest of his assets, estates and valuables. Our father died June 27th 2022, after being in a hospital bed for 6 months. Linda posted on Facebook that she wanted a puppy.

Even that we pretty early on figured that Linda was a gold digger, we really didn’t see her for what she is. When my father had a stroke and was hospitalized the Summer of 2020, we were in for a heartless surprise.

When our father went ill, Linda was ready to flee. She told a number of persons that this was not the marriage she pictured, and she could not live like this. In Norway it is customary that when you have been to the hospital and later on to the nursing home for a while, you are eventually going home. You will be provided with necessary help in your own home. Linda refused to take our father home. She stated that in a meeting with our father and the staff from the nursing home. Our father was very disappointed with her and said: “ I have taken care of you for 17 years, and now you will not help me?”. The whole crowd of people were chocked by her heartlessness. He then asked her to

leave, which she didn't. From that day Linda has been working against our father's wishes, and making a war against us, his daughters.

Having not being close to our father the last past years, this was an incident that naturally brought us all back together. We offered to help, which Linda didn't. She was very busy working against him and us. After a while our father came home, despite Linda's attempt to keep him away.

Prior to our father's stroke he had for a couple of years received help from his cousin to pay the bills and handle his finances. The examination at the hospital showed that our father had suffered from multiple minor strokes years back, before this bigger one. He now wanted to make his cousin officially his legal guardian regarding to his finances. We helped him to apply for this guardianship. When our father and Linda married years back, they both signed a prenup which stated that they had fully separate property. In the agreement it is specified to be all of our father's belongings, buildings, capital assets and accounts. A couple of years later our father also made a future power, which basically says that Linda is not to have control over his finances.

When our father came home against Lindas will, she changed strategy. She pretended to be the good wife, still working against his wishes. She revoked his apply for guardianship. He was suffering from dementia, and she dragged him from lawyer to lawyer trying to change his former statement. She became obsessed with getting access to his saving accounts. And she did. She dragged him to the bank, more than once, to get him to sign

her in. Our father didn't at that point understand what he was giving her access to. She was telling him that there was no money for food to get access to more, which clearly and provable was a lie. We were shocked to see her actions and lies. She is deceitful and very manipulative. She was telling him all kind of lies about us, making him angry and clearly driving a wedge between us. This was she doing for one purpose only, to get a hold of his money and all of his values and belongings. A few years back she got him to sign a Will, leaving everything to her. She was obsessed with the will, and thought we were talking about that whenever we came by. We actually never discussed that with him.

The irony is that SHE was telling our father that we were out to get his money, we were his greedy daughters and we were stealing from him. We have never asked for, nor taken anything from him. We have however received a part of our maternal inheritance, which our father was obliged to pay when he married Linda. It was nothing we forced him to do, but required by Norwegian law. We offered him to put of the inheritance, making an agreement that Linda could get the house in Florida, and then after his death his three children should inherit him. This was in fact a very generous offer, not recommended by any lawyer, because it meant that it potentially could be nothing left. We were NOT after his money, and have never been. This agreement never happened, because Linda was not happy with what she was given. She wanted more. A lot more. She wanted it all. Every person that sat foot in their house had to listen to Linda going on and on about the Norwegian laws and

the maternal inheritance he was committed to give his kids. It made her really angry, despite it wasn't any of her business.

After the stroke our father was literally locked up. When she was home she decided whether we were let in or not. When she was gone, he was not able to let anyone in. She changed the code at the front door. Our father wasn't given the code. We arrived SO many times at his house, standing outside listening and watching our father calling us in –not being able to access because of her. She would cover the windows, put on the extra lock and go to another room. Our father would call her again and again, not being able to leave his chair and later on his bed. He was neglected and psychically abused. There were NO PEACE around Linda. Constantly nagging about the horrible daughters, the money and the Testament.

We felt so very sorry for our father. He was living in a very stressful environment. The worst part was him believing her scam and lies, when all we really wanted was to be with him and help him.

He wasn't fed properly. He was given mostly cookies and snacks. Always hungry when we came by. When he arrived at the nursing home they stated that he was severely underweight and dehydrated. She didn't care to do a thing for him. We would bring him dinner and lunch, putting it in the fridge (when we were allowed inside that was). It would stay there until it went green. All she had to do was heat it, she couldn't care less. His health became gradually worse. He was suffering from dementia, and among other things, he had especially problems with his kidneys. His home condition didn't make things better.

He received home health whenever he needed it. They usually came by twice a day, and if he called them they would come extra on request. By Christmas 2021 he was lying full time in his bed.

Another problem she created was denying us, his daughters, to be next of kin. Whenever she wasn't around, especially when he went to the nursing home, he would say that we of course should be given information about his health. Whenever Linda found out about it she would create a lot of spectacle and we would be off the "next of kin" -list. It really bothered us. We were living far away, couldn't receive information by phone, and she would never inform us. He could be dying without us knowing.

We felt that we were forced to ask the Court to help our father. The Court can appoint a legal guardian if it is needed. This is an unusual thing to do, but in this case Linda demonstrated really unusual behavior. We have never ever met somebody like Linda. It seemed like unusual actions were needed.

Trying to shorten the story. There was a court case. It was documented and proven that Linda stole his money and assets. It will be an upcoming police investigation based on the fact that was revealed in the court. The verdict also stated that our father needed a guardianship BECAUSE of his wife. She was taken advantage of him, keeping him isolated and obstructing medical care. In addition to this, there has been a number of illegal actions done by Linda, and she will have to answer for those too in court again. A guardianship was put in place immediately.

Two horrible years ended up with our father dying at the nursing home. We invited Linda to take turn, sitting by his bed when we knew that there was very little time left. She couldn't commit, she had "a full schedule". She hasn't had a real job since she left 3abn. She was busy appealing the court case. Our father was disappointed (again!) that she spent so little time there. He said she only came by to collect his signature. The signature she had used for two years. Buying services and things in his name without paying for the bills when they arrived, leaving him with a lot of claims and dept.

That night, when he was dying, she barged in started to film his death. We respectfully asked her to quit. The nurse demanded her to quit. We urged her to quit. The home health called the police! She was rude. She yelled out while she was filming: I'm his wife, I'm his next of kin and I'm his Power of Attorney!! She didn't hold his hand, she didn't spoke comforting, she didn't touch him while he was lying there. This was a very dramatic and disturbing experience to us. He deserved a peaceful death. Linda doesn't know much about relationship. Every time she used the word WIFE about herself, it had to do with power and control – never love.

We have received SO much hate from Linda. All the crazy things she accused her ex-husband for years ago, has also been thrown at us. Harassment, abuse, lying, forged documents, surveillance, cloning phones, money under the table, breaking in, stealing all

kind of stuff, stealing 5 million each, tampering with her car,
you name it!

Frankly, you cannot believe a word coming out of her mouth.

Linda is not a victim, as she loves to give the impression of. She
leaves victims behind.
